10.1 Advertising and Environmental Education Tips for Marinas

The marina office is usually the first point of client contact, so this is an important place for education including:

- Bulletin board displays and copies of:
 - Waste disposal locations and information.
 - Marina environmental policies.
 - Copies of lease provisions that relate to clean boating.
 - Educational materials that remind boaters about clean boating habits.

NOTE: Display clean boating brochures and pamphlets in upright, clear plastic holders, if possible, because they will be:

- More noticeable
- More wind resistant
- Provide a "WECOME" packet that includes:
 - "clean marina" policies.
 - a list of onsite and nearby environmental services that support clean boating practices.
- Provide "clean boating policies" in lease provisions.
- Send staff out to meet and greet new slip tenants and provide clean boating education materials.

NOTE: Staff, or volunteers, can attend a "DOCKWALKER" training where participants are trained to teach boaters sound environmental practices and to hand out brochures on clean boating. You can also host a training session on site.

Marine supply shops on site are often a second point of contact, after the main office.

- AGAIN, have clean boating information on display in clear, upright displays.

- Have associated clean boating products available for purchase.
- Insert clean boating information into shoppers' bags.
- Print clean boating tips on the back of cash register tape.
- Provide a free bar of environmentally friendly soap with the wrapper printed with "choose phosphate free, non-detergent based soap that is instead vegetable or citrus based" and your facility logo.
- Develop clean boating inserts for monthly billing.
 - Distribute tide charts with clean boater information printed on them.
 - Print clean boater information in newsletters.
 - Share or provide clean boating information to:
 - Tenant Associations
 - Yacht clubs
 - Other boating clubs/groups that meet at your facility

NOTE: Clean Boating information can also be displayed at local ferry offices.
